1. News from or about the VA:

A. The Executive Director of the Veterans Assistance Network offers his help for Mesothelioma.

Carl Jewett is the Veteran Liaison for the Mesothelioma Center (Asbestos.com); is a retired Lieutenant Commander in the US Navy. B. Vets Urged to File 'AO' Claims Now, Not Wait for Reg. Military.Com

Tens of thousands of Vietnam veterans with ischemic heart disease, Parkinson's disease or B cell leukemia should file claims now with the Department of Veterans Affairs for disability compensation, not wait until VA publishes a regulation officially linking these diseases to wartime service. Advocacy groups are urging the swift filing of claims because veterans eventually found eligible for disability pay for these diseases will be able to receive compensation back to the date their claims were filed. Those who wait for a regulation to add these ailments to VA's list of diseases presumed caused by exposure to Agent Orange and other toxins used in the war could lessen, by several months of compensation, any retroactive pay that they will be due once their claims have been approved. "File your claim now so you can get what you've earned," urged Peter S. Gaytan, executive director of The American Legion. VA officials, in a statement, agreed. "The only way an eligible Vietnam veteran can lose out is if he or she delays filing or does not file a claim, as the effective date of benefits hinges on the date of actually filing of the claim," the VA explained.

C. VA Issues Phone-Scam Warning

The Department of Veterans Affairs is advising veterans to beware of anyone seeking to obtain personal information, including Social Security or phone numbers, via telephone. According to the American Legion, a veteran notified VA officials after receiving a call from someone purporting to represent a VA pharmacy. The caller asked the veteran numerous questions. The veteran noticed through caller ID that the call originated from (888) 555-1234, a number known by law-enforcement authorities to be the source of numerous reported scams. Sometimes a caller will tell a veteran that an identification card has expired and a fee is required to renew it, or that a bank account is listed on a computer and verification of the

number is required for its removal. The VA does not conduct business in these manners.

D. Shinseki Vows to Reduce Backlog

One year into his job as chief of the Dept. of V A, Secretary Eric K. Shinseki reaffirmed his commitment to focus on reducing the backlog of pending disability claims. The number of veterans awaiting resolution of claims for pensions, health care, and disability compensation is nearing one million and rising steadily. Shinseki promised, "We are going to break the back of the backlog this year," in an April 6 statement. Veterans can probably expect in the near future to have the VA provide them a checklist of items they will need to complete their applications. Also, Shinseki said that the VA will switch modes from adversary to advocate for applicants, improve communications, and debug the system before there is any chance that glitches be incorporated in plans to automate the application system.

A. 1st female Air Force general dies at age 88 by Valerie J Nelson, Los Angeles Times (extract) Jeanne M. Holm, who played a pivotal role in opening up the military to women and who was the first female general in the Air Force and the first in any branch of the military to become a two star general, has died. Her military career started when she drove trucks for the Women's Auxiliary Corps during WWII. Prior to Holm, women in the AF were largely viewed as vast secretarial pool.

B. Congress Takes Action on TRICARE

Congress has taken steps toward putting military people at ease over how benefits will be protected under the new health care reforms and to extend benefits for older children. But Congress continues to take only clumsy temporary steps to relieve another source of anxiety for Medicare and TRICARE users -- a scheduled 21.2 percent reduction in reimbursements to participating doctors. If such a cut were allowed to take effect, it could severely crimp access to care.

C. 6 More names added to the VN Memorial Armed Forces News 7 May 2010 The names of six service members who died as a result of serious injuries they sustained in action have been added to the Vietnam Veterans Memorial in Washington, D.C. Army Lt. Col. William Taylor, Capt. Edward Miles, and Sgt. Michael Morehouse, and Marine Corps Cpl. Ronald Vivona and Lance Cpls. John Granville and Clayton Hough Jr., joined the list of 58,261 members of the U.S. armed forces who either were killed or are missing in action as a result of their service during the Vietnam conflict between November 1955 and April 1975. Though all six men survived the war, the Defense Department has determined that they later died because of maladies they incurred during service in the combat zone during the war.

D. The Medal of Honor in Vietnam The medal is relatively rare. Of the 2.1 million men who served in Vietnam, 246 earned it -- 154 of them posthumously. Military.Com, 13 May 2010

B. Did You Know? USAF rebuffs group looking to refurbish F-105

A Vietnam-era fighter is pitting a nonprofit group that restores old airplanes against the Air Force, its source for the mobile museums. The Collings Foundation wants to refurbish an F-105 Thunderchief and fly it at air shows across the country. The Air Force is refusing to make the donation because the 100 or so F-105s it still owns don't meet flight or safety standards and would be a liability if an accident occurred. This issue has been referred to congress.

"There are a number of regulations and policies in place which restrict our ability to donate aircraft to outside agencies, particularly if the intent is to fly the aircraft," Gen. Howie Chandler wrote "Given this," the letter reads, "the Air Force cannot support any legislation directing the transfer of an F-105 from the national historic collection."

Lewis disagreed. "Like the other planes that have been sent over to us, the [Air Force] releases the liability," Lewis said. "We sign a hold-harmless agreement. There's no cost to the government." The foundation is pressing so hard for the Thunderchief because the service is scrapping the few that remain, Lewis said.

The Air Force began flying the F-105, also known as the "Thud", in 1958 and relied on it heavily in Vietnam for both flying bombing runs and attacking surface-to-air missile sites. Of its 833 Thunderchiefs, the service lost almost half in Vietnam and started phasing out the aircraft in the mid-1970s. The final F-105 was retired in 1984.

The Air Force Association supports the transfer, provided the Air Force is freed of all liability.
